

Itinerary for your tour "Experience Magical Oman"

Program details:

Day 1 - Arrival at Muscat Airport

Meet and greet with the driver and transfer to your hotel for check-in.

Overnight at Hotel Ramada Encore by Wyndham Al-Ghubra 4*, Standard room incl. breakfast.

Day 2 - Along the coast to Sur - 250km/3h

After breakfast, we start the tour and enjoy the drive along the coast towards **Bimah Sinkhole**, **Wadi Tiwi** until **Sur**, which is an ancient boat building capital of the region. Depending on the season, turtle watching could be experienced (additional fee payable on spot).

Overnight at Sur Plaza hotel 3*, Standard room incl. breakfast.





Day 3 - Wadi Bani Khalid - Wahiba Sands - 250km/4h

On the way to the desert, we will stop in **Wadi Bani Khalid** to walk over the Falaj into this beautiful oasis with its clear blue water pools. Enjoy the ride up the desert dunes of **Wahiba Sands** for a stunning sunset later in the day. Overnight at **Sama Al Wasil Camp, Standard chalet** incl. dinner & breakfast.





Day 4 - Ibra - Birkat Al Mouz - Jebel Akhdar - 220km/3:15h

After breakfast, we visit a **Bedouin family** and experience the life in the desert, they provide the option to ride a camel. We continue to **Birkat Al Mouz**, visit the UNESCO Falaj Al Katmain, and enjoy a drive through the palm plantations. We drive up the majestic mountain range **Jabal Akhdar** on 2,000 meters height. The cool climate is perfect to walk along the Falaj and through the ancient villages.

Overnight at Sama Al Jabal Akhdar hotel 3*, Standard room incl. dinner & breakfast.





Day 5 - Bahla - Jabreen - Misfat - Nizwa - 190km/3h

After breakfast, we drive to **Bahla** for a photo stop of a panoramic view before we visit the famous **castle of Jabreen**, built between 16th to 17th centuries by Imam Bal arab ibn Sultan. Continue to **Misfat** with its mud buildings and agricultural terraces on 1,000 meters height before heading to **Nizwa**.

Overnight at an authentic Heritage Guesthouse, Standard room incl. breakfast.





Day 6 - Nizwa - Muscat - 250km/4.5h

We proceed to **Nizwa** to visit the local Souq that is renowned for its hand-carved "Khanjars" (daggers), dates souk, pottery, ornamental silver jewelers and much more before we continue back to Muscat.

Overnight at Hotel Ramada Encore by Wyndham Al-Ghubra 4*, Standard room incl. breakfast.

Day 7 - Muscat Morning City Tour

We introduce you to Muscat during a morning half day city tour. It begins with a visit of the majestic **Sultan Qaboos Grand Mosque**, a religious landmark of Muscat and splendor of unique Islamic architecture (*Ladies should cover their head with a scarf and wear long-sleeved clothes. Men should wear long trousers and t-shirt with sleeves, the mosque is closed on Friday*). We continue to **Mutrah Souq**, which is a great opportunity to buy frankincense, gold, silver and other souvenirs. Enjoy the drive along the beautiful Corniche to **old Muscat** for a photo stop at Al Alam Palace. On the way back to the hotel, we stop for a picture at the **Royal Opera House**.

Overnight at Hotel Ramada Encore by Wyndham Al-Ghubra 4*, Standard room incl. breakfast.





Day 8 - Departure

Check out at the hotel and the driver will pick you up from the hotel to Muscat International airport for the departure.

Cancellations/No Shows/Changes:

- 1. Tourism Services may be changed or cancelled from time to time provided that valid reasons must be shared in advance. Parties may not send any cancellation notices invalidly and/or unreasonably.
- 2. Service Provider shall always have the right to seek a compensation equivalent of any total invoiced amount if the Service Receiver has decided to cancel or it is a no show for any of invoiced Tourism Service within the cancellation period of Service Provider or third party suppliers before the commencement date of such Tourism Services.
- 3. Any charges invoiced by third parties pertaining the cancelled Tourism Services will be always payable by the Party requested to cancel such Tourism Services.
- 4. In all events including Force Majeure, the Service Receiver is requested to pay the Service Provider any charges or costs incurred initially and to any Third-Party services providers but not limited to bookings charges, drivers (etc.).

5. Free cancellation/changes until 10 days prior to arrival. Later cancellation as per following breakdown: 10-7 days 50% of total package / 7-0 days & no-show 100% of total package.
Al Maamari Tours highly recommends to take out a travel insurance covering any cancellation fees related to Covid-caused cancellations. In case of cancellation, a non-refundable admin service fee of OMR 50 will be applicable.

Payments of invoices, billings and taxes:

- 1. Rates are incl. all taxes.
- 2. Parties agree that entire invoices and bills issued between themselves must be paid and done in Omani Rials only. However, bank charges and taxes shall be excluded if any payments were made in foreign currency by a Party towards the other hence, bank charges and taxes shall be always borne by the payer.
- 3. Parties agree that Service Provider will send an invoice for the Tourism Services based on proposed net rates as soon once the booking details are shared by the Service Receiver. Service Provider shall have an exclusive right to hold any obligations and carry out the agreed Tourism Services if any invoices were not settled.
- 4. Service Receiver agree to pay the charges and rates pertaining the Tourism Services, set out as per above details.
- 5. Service Receiver agree to pay any invoices or/and billings for any Tourism Services immediately and as per payment details mentioned on the invoice/bill.
- 6. Amounts payable to Service Provider must be done to its registered account or via cash money transfer as per the details mentioned in the invoice.

Force Majeure:

- 1. Without any prejudice to the obligations of the Parties set out in this Agreement, Service Provider shall remain free of any liability against any failure to perform any obligations resulting of Emergency Circumstances, Act's of God, acts of governments or other authorities, wars, weather conditions, hostilities, civil disturbances, strikes, riots epidemics, quarantines, COVID-19 restrictions issued by the governments and affecting the enforcement of this Agreement or as a result of any cause beyond the control ("Events of Threats").
- 2. Service Receiver realizes that Events of Threats could prohibit Service Provider from carrying out its obligations entirely or partially and therefore, assessment of liabilities shall not strictly made or calculated immediately against the Service Provider.

Travel & Health insurances/Visa:

- 1. Al Maamari Tours shall have no liability against any failure of insurance or visa requirements to enter the Sultanate of Oman. Please contact the Royal Police of Oman for further information: https://evisa.rop.gov.om/.
- 2. The passenger/guest has to strictly follow the implemented decisions & regulations taken by the Omani authorities. In case of violating the quarantine regulations, Al Maamari Tours shall have no liability against any fines or punitive actions taken. Please find updated information for travel regulations here.
